In Nepal, there are four accredited universities such as Tribhuvan (https://tribhuvan-university.edu.np/), University Kathmandu University (http://www.ku.edu.np/), Pokhara University (https://pu.edu.np/edu/), Purbanchal University (http://www.puexam.edu.np/), and along with colleges such as Amrit Science Campus **NIMST** (http://nimstcollege.edu.np), British College (https://edusanjal.com/), (https://www.thebritishcollege.edu.np/) and Saint Xavier (www.collegesnepal) but unfortunately available seat is limited. Moreover, lack of practical training is the main drawback in educational system of Nepal. Education should be a perfect blend of theory with practical which will provide solid ground for students for their careers. I found it majorly lacking in Nepal. The lopsidedness

between theory and practical has made more students in Nepal unsure about their careers.

Though Information Technology course is also taught in Nepal but I don't wish to continue my further study in Nepal because of the following reasons:

- Education is theoretically driven which is not enough for students to get successful career.
- Limited number of seats for enrollment.
- Obsolete course structures.
- > Graduates of Nepal can't compete with international graduates in global market.
- > High demand of international graduates in multinational companies of Nepal.
- > There is absolute lack of enough practical training in academic years.
- > I can afford quality education from international education providers.
- > Does not contain online teaching.
- > Not a globally recognized degree.
- > Lack of advanced technology.

So considering these facts I have to take major decision to leave Nepal for better education to secure my future in Nepal after returning back to Nepal with heavy knowledge that will qualify me for any workforce.

WHY AUSTRALIA?

For every student it is actually very hard to make major decision for their careers. In fact, they have to choose major decision to build their career in solid ground. For this education plays an important role as it is a foundation upon which we build our future I am not hectic person rather I always take abundant time deciding each and every decisions. Therefore, deciding suitable country for my further education has taken my time and considerations. After numerous and intensive researches, I found Australia as most suitable destination for me. There are various factors that I have researched thoroughly such as educational and educational aspects including climates and others.

In terms of Education, Australia is stellar in providing high quality education. Similarly, The Tuition Protection Service (TPS) which is included in ESOS Act is a placement and refund service for international students, if educational institutions are unable to provide student's interested courses. These initiatives of Australian government have given international students a better chance of getting high quality education without insecurities for future.

Therefore, after numerous researches on every aspects of Australia I found Australia as best education destination to vigor my knowledge more in my interest of field. In fact, I would get more technical skills with industrial based education and that is what I am going to treasure most after returning to Nepal.

WHY NOT OTHER COUNTRIES?

I also researched about other countries like Germany, Japan, and China including other English speaking countries like US, UK, CANDA, and New Zealand but finally landed on Australia. I chose Australia instead of:

- 1. CANADA: Although Canada is one of the popular choices as education destination for international students, I believe for me its climatic condition would be difficult for me to coop with. Their weather condition is extreme cold with average temperature of -19. 7 degree centigrade whereas the climate of Australia is almost same as in Nepal. Entry requirement and entrance process is very difficult and lengthy. Canada also has very less intake dates.
- 2. USA: In spite of being the first choice as education destination of most of the international students, the education in USA is very costly; if we do not get any scholarship or assistantship it will be hard for us to pay tuition fees. From living costs to tuition fees, the expenses are staggeringly high. In my case, it is after conversion the expenses are higher than that of Australia. USA has great value of education and the education system is well renowned all around the globe. But USA does not provide the Tuition fee Protection Scheme (TPS) and Overseas Student Health Cover (OSHC). Another aspect is that the crime rate in USA is very high. The climatic condition



- of USA is very different from Nepal and so is the time difference. Also each state in USA follows different curriculum of courses creating student of varying standard of education.
- 3. The countries like Germany, France, Japan where priority is given to their native language, the student have to take different language classes to study in their universities. Also it is not safe for international student as we can be misinterpreted there due to language gap.

Considering these factors, I excluded USA, Canada and other European and Asian countries as my educational destination.

WHY SYDNEY?

Sydney is the state capital of New South Wales and the most populous city in Australia and Oceania located on Australia's east coast. Sydney is recommended by 88% international students as best educational destination which has shown the popularity of Sydney among international students. Similarly, it is ranked 9th best city for international students in the world; according to QS Best Student Cities 2018. Therefore more than 50, 000 international students come each year for their study. Not to mention the fact that it is center of World-class educational institutions (including Macquarie University, the University of New South Wales, the University of Sydney, the University of Technology Sydney and Western Sydney University) and currently Sydney has 5 universities in the QS World University Ranking, with the University of Sydney and the University of New South Wales in the global top 50. These facts have incited me more to choose Sydney for my better education. In fact, I will surely feel blessed to get international high quality education from Sydney.

Living in Sydney will give senses of security knowing Sydney is the world's second friendliest destination according to the Economist Intelligence Unit's 2016 global livability survey on 140 cities in the world. As per my research I also found the VET education providers like Kingsford Institute, Vibe College and TMG but my interest to the Sydney is so intense that I excluded the Vibe College (Brisbane), which only provides Advance Diploma Network Security without the Diploma of IT networking. Kingsford International Institute which is situated at Sydney unfortunately doesn't provide Diploma of IT networking and Advanced Diploma of network security that I passionately want to study to secure my future goal to become a network security analyst.

AHIC is centrally located in Sydney CBD, which makes transportation easier as there is a train station within 2 minutes of walk. From the counseling, I got adequate knowledge of internal factors of AHIC.
